YEUNG CHING LOONG, ALEXANDER

Executive Director and Chairman

Mr. Yeung Ching Loong, Alexander is an Executive Director of the Company and Chairman of the Board. He is also the Chairman of the Executive Committee and a member of the Remuneration Committee of the Company. Mr. Yeung is responsible for leading the Board and managing its work to ensure that the Board effectively operates.
